MISCELLANOUS TOPICS OF INTEREST:

- There was a total of **34** arrests and **42** charges.
- Patrol officers participated in numerous parades in celebration of kids and residents who could not have a party due to COVID-19.
- The department continues to adjust strategies in how it provides services to the community while maintaining the health interests of the employees as well as those they encounter.
- Several complaints about businesses in violation of the Stay at Home order. Complaints passed to the BC Health District for review.
- Evening shift officers responded to the 1900 block of Allstatter Avenue for a fight call. Upon arrival the male
 victim stated the suspect struck him multiple times with his fists and threatened to shoot him. The suspect
 fled the area prior to officers arriving. Warrants were filed for assault and aggravated menacing. The suspect
 is currently on parole out of Hamilton County.
- Officers responded to the 1900 block of Allstatter Avenue to assist Hamilton County Parole in finding the male suspect from the above incident. During that time, officers located the suspect's girlfriend who had been beaten by him. The victim sustained a broken jaw, broken nose, and broken wisdom teeth. Officers located the suspect the next day and arrested him for domestic violence, felonious assault, parole violation, and other multiple charges.
- Officers responded to Menards for a subject involved in a theft. That individual received an early release from prison due to COVID-19 and during that timeframe he committed this theft and had three felony warrants.
- Multiple calls for service (assault, runaway) involving juveniles at the One Way Farm.
- Officers recovered a stolen vehicle out of Sharonville in the 7700 block of Wildbranch Road.
- Officers were conducting a business check at UDF on Tylersville Road when they came in contact with a male in the men's restroom impaired on drugs. He had several needles and a drug pipe in his possession.
- At 4:38 am on April 4th, officers and Fire Department responded to a structure fire at 3969 Hassfurt Drive. A significant amount of the residence was on fire. All household members were able to get out on the house safely. Two dogs and a cat were not found at the time of the fire.
- Officers responded to the area of Gateway and Wildbranch for an active fight involving two females, one
 possibly in possession of a stick. One of the females was uncooperative and combative and was arrested for
 assault, assault on a police officer, obstructing official business, and resisting arrest. The officer was not
 injured.

- Officers responded to the 1800 block of Parkamo Avenue for an overdose. A male was found in the yard after taking Fentanyl. Officers located several needles nearby and the subject was transported for medical attention and charged with possession of drug abuse instruments.
- Report of an assault at Glen Meadows on Hamilton Mason Road. The victim suffered multiple injuries to the face, including broken bones in the jaw. Assault charges filed on the suspect.
- Officers stopped a black Dodge Stratus for a mark lanes violation on SR4 near Greenlawn Road. There was a strong odor of marijuana coming from the vehicle and several separate, sealed bags of edibles [believed to be marijuana] were found in the vehicle. The items were sent to the crime lab and charges are pending.
- Officers stopped a vehicle after it left a house in which a male subject was wanted on felony warrants. Officers
 located the male in the vehicle and arrested him and booked him in the jail. Another passenger had warrants
 out of Trenton PD.
- Officers stopped a vehicle for traffic violations traveling westbound on SR129. Officers subsequently arrested the male driver for OVI, and he also had felony juvenile warrants. Additional evidence was sent to the crime lab.
- Officers responded to Beagle Court for a fire in the front yard near the front of his house. The heat of the fire started to melt the siding near the garage before the fire was extinguished. The male resident was highly intoxicated and found to have mental health issues and transported to the hospital for treatment.
- Officers responded to an address on Exeter Avenue at 5:04 a.m. for a domestic incident. The male and female in the residence were intoxicated and physical with each other. Officers arrested both subjects and booked them into the jail for domestic violence.
- Officers responded to the area of Lenox and Parkamo for a shots-fired call. Hamilton PD checked their area also. The shots appear to be coming from the 2100 block of Parkamo, an area where there is an ongoing neighbor dispute. The parties involved are known to be intoxicated and have bonfires with friends. A false structure fire was called into dispatch in that same area a couple hours later; however, nothing was located.
- Officers responded to the 2000 block of Fairfax Avenue for a sexual assault. A male subject reportedly
 assaulted a female victim in the residence. Investigators were called-out and following an investigation, the
 male subject was arrested and charged with Gross Sexual Imposition (felony of the 4th degree).
- Officers responded to SR4 and Headgates Road for a road rage incident involving an assault. A female driving
 a car reported a male subject on a motorcycle had been driving recklessly in front of her and he got off the bike
 and punched her car hood multiple times. The female exited her vehicle to confront the male and the subject
 kicked her in the groin and fled the area. The subject was identified shortly after the incident and officers
 located and arrested him.
- Officers responded to Treadway Trail for a dispute between a male and female. Officers learned the female intentionally rammed her vehicle into another vehicle to prevent that driver from leaving. She was arrested and booked into the jail.
