## MISCELLANEOUS TOPICS OF INTEREST:

- There was a total of **60** arrests and **68** charges.
- Amid COVID-19, the department continues to provide services while maintaining the health interests of the employees, those they encounter, and the community we serve.
- Four of the probationary officers successfully completed in-service training and qualified with rifle and less lethal.
- On May 4<sup>th</sup>, officers and detectives responded to the 1900 block of Allstatter Avenue for a report of a female victim being sexually assaulted and held hostage inside a house. After some time, the incident came to a successful conclusion and the victim was released and transported for medical attention. Officers arrested the suspect and booked him in the jail for Kidnapping and Rape.
- Officers responded to the 3400 block of Waterfowl Lane for shots fired. Officers recovered multiple casings and several rounds hit apartments and vehicles. Detectives are following leads and the case remains under investigation.
- Officers responded to the 2300 block of Canal Road for a single-vehicle rollover crash. The driver, 65-year-old Sally Gecks from Cincinnati, was ejected from the vehicle during the crash and later pronounced dead at UC West Chester Hospital.
- Officers responded to a large fight (15 or more people) in the 2000 block of Allstatter Avenue. A vehicle fleeing the area failed to comply with officers' orders and almost struck the officers. A female tried to get out of that fleeing vehicle and fell out while it was speeding off. Suspects were identified and warrants signed; the driver is a known gang member who carries a firearm.
- Officers responded to a call for subjects with baseball bats outside a house on Parrish Avenue. Officers located two of the subjects and one of them had a felony domestic violence warrant out of Hamilton. The subject failed to comply with the officers and physically resisted arrest. In response to the subject's aggression, the officer applied a drive-stun with a Taser and were able to gain control of the subject and arrest him.
- Officers responded to a disabled vehicle in the 3800 block of Millikin Road. Officers located a male and female in the vehicle and recovered a large amount of marijuana, syringes with unknown substance, drug paraphernalia, and .45 caliber handgun.
- Midnights shift officers responded to Advantage Self Storage on Tylersville Road for an unwanted male and female on the complex after hours. The two claimed to be moving items from one storage unit to another. The female was entered into NCIC as a missing person and had a nationwide pickup warrant out of Kentucky. She was taken into custody and booked into the jail.

- Officers received information of a possible stolen vehicle in a garage in the 2000 block of Parrish Avenue. Officers located the vehicle which was entered stolen from Colerain Township. Parts of the vehicle were already removed and spray-painted.
- Midnight shift officers stopped a vehicle for driving 80 mph on SR4-Bypass and several mark lane violations. The driver, who was operating the vehicle under the influence of alcohol and/or drugs, was a CCW permit holder and had his loaded firearm in the vehicle with him. He was arrested for OVI and Improper Handling of a Firearm.
- Officers responded to the 3200 block of Tuscarora for a male unresponsive in the grass near the road. Officers gave him Narcan and saw he was extremely intoxicated. He was identified and transported to Bethesda Butler by life squad.
- Midnight shift officers responded to the 1900 block of Exeter Street for an injury crash. Officers located a van on its side and another vehicle crashed into a house. The van struck two parks cars causing one of them to go off the roadway and crash into the front porch of the house. The driver was highly intoxicated and had a severe hand injury. He was transported to a medical facility for his injuries and arrested for OVI.
- Officers responded with EMS for a female having a baby in the 2700 block of Eastridge. The female delivered the baby at home before responding units arrived. The officer arrived and assisted until EMS arrived.
- Officers responded to the 1400 block of Exeter Street for an overdose. A 51-year old male was given Narcan and transported to Fort Hamilton Hospital. He was home alone with his 10-year-old granddaughter. The grandmother was contacted at work to come home and care for the juvenile.
- Officers responded to 7700 block of Wildbranch for 911 hang call. Three juveniles under 10-years-old were left at home alone while their mother/guardian went to Cincinnati to pick up a baby. The mother arrived home having a strong smell of marijuana about her person. The police report was sent to BC Children Services.
- Officers responded to Dollar Tree on Gilmore Road for an active assault. An irate customer punched the cashier in the head. Officers arrested the subject for assault.
- Evening shift officers responded to Lester Avenue for a domestic call. The female victim had serious visible injuries to her face and body. Officers located the male suspect walking toward Sparks Lane and arrested him for felony domestic violence (F4) and transported him to the Butler County Jail.
