## **MISCELLANOUS TOPICS OF INTEREST:**

- There was a total of 69 arrests and 76 charges.
- The police department collaborated with two residents and held a community engagement event called, "Strategies for Youth." There was an excellent turnout and the successful event consisted of a meet and greet between police officers and residents, a Q&A session, food, and a DJ playing music.
- Detective Tinch requested a transfer from investigations back to road patrol. Tinch served as a detective since January 29, 2018. Five officers submitted their interest in the available position. Following the interview process, Officer Emma Edens was selected to fill the position and will start her new assignment on July 7<sup>th</sup>.
- On June 14<sup>th</sup> dayshift officers were invited, and attended, a community event at the Christ Tabernacle Church on Hamilton Mason Rd. They had lunch and a very positive interaction with the parishioners.
- On June 1<sup>st</sup> a critical missing report was taken for an adult male, Michael Allen McKenney. His vehicle was found at Hueston Woods, but he has not been located. Investigation is ongoing.
- On June 3<sup>rd</sup> a stolen vehicle report was taken in the 2600-block of Fairfield Ridge. The car was later located in the City of Hamilton and the owner recovered the vehicle with no damage found.
- On June 18<sup>th</sup> officers took a missing person report for an adult male. This case remains under investigation by the detective section.
- Units responded to Cheyenne Ct. for a domestic that resulted in a male being stabbed in the lower leg with a pair of scissors that were thrown at him by his wife. She was arrested for felonious assault and domestic violence.
- Rubin Hibbard III was indicted for 2 counts of Rape (F1) & 2 counts of Kidnapping (F1) stemming from a standoff in early May. He remains in jail on \$100K bond. The case is pending in front of Judge Pater in Common Pleas Court.
- Three juveniles from the One Way Farm were charged with Grand Theft (F4) after stealing a vehicle belonging to the facility, then drove to Cincinnati during the protests. The One Way Farm has since recovered the vehicle and all three have their cases pending in Juvenile Court.
- A subject smashed the front window out at Claire's (Bridgewater Falls) overnight, gained entry, and stole money.
- On June 5<sup>th</sup> dayshift officers took a hit-skip accident on Princeton Rd. at Satrialle Way. A male rear-ended the victim's car and then he fled the scene. The victim was able to get a license plate number and the driver has since been identified and warrants issued.

- Midnight shift officers responded to the 1600-block of Tuley Road for an assault report. A 29-year-old female stated that her boyfriend put her in a choke hold during an argument causing her to pass out from not being able to breath. She had visible marks on her neck and other parts of her body. The boyfriend also broke her cell phone so she could not call 911. Multiple felony charges pending.
- Officers responded to Hamilton Mason and Sparks Lane for a female laying in the middle of the road and a male trying to get her in the car. The female advised she felt like hurting herself, so she laid in the roadway. She was evaluated and transported to a local hospital for evaluation.
- Officers responded to Preakness Drive for a welfare check on a female with multiple bruises to her face. The victim had several large bruises and black eyes. She stated the male suspect had been beating on her for the past several days. The male suspect was found passed out drunk in the living room and officers arrested him for Felonious Assault (F-2) and Domestic Violence (M-1).
- All units responded SR4-Bypass at SR129 (eastbound) for a rollover injury crash involving two units. A child was transported to Liberty Children's for evaluation and the at-fault driver was cited for failure to yield and no driver's license.
- Officers responded to Beagle Court for a possible domestic issue. Officers learned a 12-year-old cut her mother's thumb with a knife. The juvenile was taken to JDC for felonious assault and domestic violence.
- Officer responded to the area of Lenox//Parkamo for another fight. Officers arrived and found an injured subject who said two men assaulted him. The investigation concluded one of the subjects used a baseball bat as a weapon and officers made multiple arrests including charges of aggravated menacing, assault, and disorderly conduct.
- Officers located a suspect vehicle from a harassment report and located a handgun and ammunition during a
  vehicle search. Subject was charged with felony Improper Handling of Firearm in a Motor Vehicle and booked
  in the Butler County Jail where ICE also placed a holder due to the subject's immigration status.
- Officers responded to Fairfax Avenue for domestic where two females assaulted each other. Both subjects charged with domestic violence.
- Officers responded to Millikin Road for a domestic call possibly involving a firearm. Officers met with the complainant who advised his 17-year-old son was arguing with him about a firearm. Officers located and confiscated a loaded handgun in the juvenile's dresser drawer. The juvenile was charged with Domestic Violence and booked into JDC.
- Officers responded to the UDF on Tylersville Road for a vehicle that crashed into the building. Officers determined the driver was found to be under the influence and charged with OVI.
- Officers responded to Bridgewater Falls for a rollover auto accident. The driver failed to control her vehicle when entering the roundabout and struck another vehicle on the side causing it to flip.
- Parent reported that his child was possibly sexually assaulted by an adult acquaintance. This case remains under investigation.
