MISCELLANEOUS TOPICS OF INTEREST:

- There was a total of **63** arrests and **78** charges.
- The police department submitted compliance documentation for the Ohio Collaborative and attained certifications in Use of Force, Recruitment and Hiring, and Community Engagement.
- We received 56 applications for the vacant police clerk position and conducted an interview panel. We are in the final stages of the process and will make our selection in August.
- Officer Emma Edens was assigned as a detective in the Investigations Section. Detective Edens replaced Officer Daniel Tinch, who was reassigned to road patrol.
- Officer Laugle and Detective Edens recruited at Butler Tech police academy and Great Oaks police academy.
- Sergeant McCroskey attended a two-day online course (due to COVID) on Child Death Investigations.
- All sworn personnel completed their annual firearms qualifications.
- Detectives investigated a sex offense involving a 28-year-old male and his 15-year-old female neighbor. Following the investigation, detectives arrested the male subject for Unlawful Sexual Conduct with a Minor (F3) and booked him into the Butler County Jail. He was indicted direct by the Butler County Grand Jury on one count of Unlawful Sexual Conduct with a Minor (F3) and two counts of Contributing to the Delinquency of a Minor (M1). His case is pending in Butler County Common Pleas Court.
- Detectives are investigating an alleged sex offense involving a 10-year-old female and an adult relative.
- Detectives called out during midnight shift for a stabbing/cutting which occurred in the 7700-block of Wildbranch Road. The investigation revealed that two females had a fight which escalated when one of the females stabbed the other with a kitchen knife and also threw a casserole dish through the victim’s windshield. The suspect was arrested and booked into the BC Jail for Felonious Assault (F2) and additional charges may be filed at a later time.
- A 34-year-old male out of Oxford was charged with two counts of Breaking & Entering (F5), two counts of Vandalism (F5), and two counts of Theft (M1) for “smash and grab” burglaries of two township businesses (Hambro Bazaar Indian Restaurant behind Speedway on Tylersville Road and Clair’s in Bridgewater Falls). In both cases, the subject broke in by busting out the front windows and then stole money from the registers. The subject confessed and other agencies charged him with similar crimes which occurred in their jurisdictions.
- Critical Missing Person, Michael McKenney, still has not been located. His DNA has been submitted to Miami Valley Crime Laboratory to have his DNA profile entered into a national database for missing persons.
- A 35-year-old female advised that her boyfriend became irate during a disagreement and he headbutted her and threatened her with a knife. The male subject fled the scene prior to officers arriving.
- Officers responded to Speedway (Creskide) for an assault where a female punched her ex-boyfriend in the face. The female admitted to the assault and was summoned and released.

- Detectives arrested a male subject for Grand Theft of a Firearm (F3) and Receiving Stolen Property (F5) after it was determined he stole a firearm from a house on Headgates Road. The subject was also found to be in possession of a stolen license plate that belonged to the victim.
- Officers responded to the Gilmore Office Park for an assault where the complainant advised her husband's mistress showed up at the location and attacked her. Both individuals had visible minor injuries and the aggressor was arrested.
- Officers were dispatched to Tyler's Creek Townhomes for two males walking with a gun. Officers stopped and detained four males, two of which matched the description, who were standing near a car. Officers located a handgun in plain sight in the vehicle. A juvenile was arrested and booked into JDC on a felony weapon's charge.
- Officers responded to the 7700-block of Wildbranch Road for an active domestic. The male suspect was found to have choked, slammed, and kicked his girlfriend when she tried to move out of their apartment. The male subject was arrested for Domestic Violence (M-1) and booked into the jail.
- Officer responded to the 7600-block of Wildbranch Road for an active domestic. A female was arrested for domestic violence against her live-in girlfriend. The suspect was booked into the jail.
- Officers responded to the 3200-block of James Place for a dispute in progress. A male complainant and his wife got into a verbal argument with two females at the dog park. The male and his wife left, and the other two females followed them to a family member's house. The dispute continued there and one of the females threatened to shoot the resident, then got back in the vehicle and fled the scene. Officers located the two females at the back of Rose Hill. Charges filed for aggravated menacing and both had outstanding warrants.
- Officers responded to Walmart for an aggravated menacing report. The pharmacist advised a male subject threatened to bring a gun to Walmart if they did not fill his prescription in time. The male subject was later arrested and booked into the jail for aggravated menacing.
- Officers responded to the 7500-block of Wildbranch Road for a juvenile problem. While on the scene, officers learned a domestic violence incident occurred and the juvenile then came down the stairs and brandished a knife, placed it to his own throat, and threatened to cut himself. The officers were able to deescalate the situation and the juvenile dropped the knife. The juvenile was taken for an evaluation prior to being booked in at JDC.
- Officers responded to Home Depot for a male subject possibly doing drugs in his vehicle. The subject was observed to be in possession of white powder and brown powder, along with drug abuse instruments in plain sight. The subject also had warrants through BCSO. The subject was transported to the jail for the warrant and additional charges are pending lab analysis.
- Officers were dispatched to a male sleeping in a truck in the parking lot of AurGroup Credit Union on Creekside Drive. The truck was still in drive when officers approached the driver, who was determined to be under the influence of drugs and/or alcohol. The driver was charged for OVI.
- Officers responded to crash on SR4 where a vehicle struck multiple mailboxes and a tree. The driver was located running southbound on SR4 and needed medical attention. He went to the hospital and was charged with OVI.
- Warrants issued for male subject who passed multiple checks for thousands of dollars at One Stop Tool Rental.
- Officers were called to the area Hickory Trail for a male throwing rocks at a white Mercedes and standing in the middle of the road with a knife. He was located and under the influence of an unknown drug and threw the knife down before officers arrived.
- Officers responded for a disable vehicle on SR129 on the median-shoulder of the roadway. The driver could be seen attempting to change a tire and was slumped over the spare tire on the road's shoulder and was unresponsive. The female finally responded to questions after regaining consciousness and appeared to be under the influence of an unknown substance. She admitted to ingesting mushrooms and was transported to the hospital before being arrested for OVI.
