MISCELLANEOUS TOPICS OF INTEREST:

- There was a total of **99** arrests and **114** charges.
- Congratulations to Sergeant Matt Miller. Miller was promoted to the rank of sergeant following his top ranking upon completing the Ohio Association of Chiefs of Police assessment center. Miller will assume the role of evening shift sergeant.
- Congratulations to Theodore Sensel and Joseph Mitchell who were both sworn in as police officers on October 28, 2020. They are excited to be part of the township team and begin their field training.
- The police department obtained certification for the standards in all four groups of the Ohio Collaborative initiative.
- The police department received \$3,132.88 in reimbursements from the Ohio Attorney General after successfully applying for the Body Armor Program grant and submitting required documentation.
- Sgt. McCroskey and Officer Gilbert attended the carbine/rifle instructor course at OPOTA in London, Ohio.
- Officers responded to Menards for a disoriented, suspicious male subject. The subject would not comply with the officers' orders and after a short foot pursuit the officers caught the subject inside the store where the subject resisted and fought with officers, biting one of them on the left forearm. Once officers were able to get him into custody he was taken to the hospital for an evaluation and then booked in the BC Jail. The officer sought medical attention as well. Subject charged with Assault (on a police officer) and Resisting Arrest.
- Officers responded to the 6500-block of Taylor Trace Lane for an active domestic call with a gun. Both the husband and wife were arrested for striking each other and leaving visible marks. The firearm was taken for safekeeping since both parties were arrested for domestic violence and booked in the BC Jail.
- Detectives arrested a female on Misuse of Credit Card (F5). The case was bound over to the grand jury for consideration. The female allegedly used a friend's credit card to make over \$1,700 in unauthorized purchases, which was verified through various records and evidence.
- Detectives, with the assistance of multiple patrol officers, conducted a search warrant in the 4900-block of Rockdale Road in Liberty Township. Investigators recovered multiple items which were stolen from vehicles and garages in the township. The male suspect was arrested and charged with Receiving Stolen Property (F5), Grand Theft (F4), Breaking and Entering (F5), and Misuse of Credit Cards. Additional charges are pending from multiple cases in Fairfield Township and surrounding areas.
- Detectives charged a female with Burglary (F3) and Theft (F5) after observing her on video breaking into a house on Harvard Street. She remains in custody in the BC Jail and her case is pending in grand jury.

- Evening shift officers took a report of a male juvenile who said he was robbed at gunpoint in the area of Waterfowl and Bentbranch. The juvenile admitted he went to the location to buy marijuana from a male who he does not know. The male suspect has been identified and the investigation is ongoing.
- Officers responded to a domestic-related call and prior to arrival the male subject succumbed to a self-inflicted gunshot wound.
- Officers responded to the 7700-block of Wildbranch Road with HPD and the Crisis Team for a female subject having hallucinations. The female was having conversations with both demons and Jesus and was transported to Bethesda Butler by the Crisis Team for an evaluation.
- Officers responded to the 6000-block of Tyler Point to assist the crisis team with an emotionally disturbed person. Officers were met by the individual's family members who explained the subject was having some mental health issues. The individual appeared disoriented and was having difficulty in recognizing his own family and appeared disoriented. The individual eventually went with family members to seek professional help.
- Officers responded to SR4 Bypass/SR129 for a welfare check on a suspicious male subject. Officers made contact with the male who was sitting on the edge of the overpass/bridge; however, he would not acknowledge the officers. He appeared to have suicidal tendencies, and officers were able to safely pull him from the edge and secure him. He was transported to a medical facility for an evaluation.
- Officers responded to the 3400-block of Hamilton Mason Road for a hit-skip crash that doubled as a vehicular assault. Officers located a female who was struck by a vehicle that already left the scene. It appears the subjects were intoxicated at a party and were on their way home when an argument broke out in the car between several people. The driver stopped the vehicle and at some point, some of the passengers were forced out of the vehicle. The driver took off and ran over the victim's leg and it appears she broke her foot.
- Officers responded to the 6400-block of Zoellners Place for a motor vehicle theft. Another call came in from Zoellners Place where subjects broke into a vehicle and stole multiple items. This case remains under investigation.
- Officers responded to the 2500-block of Eastridge Drive for a stolen vehicle report. This case remains under investigation.
- Officers responded to the 4000-block of Schroeder Drive for a violation of protection order. The female victim states the male suspect has shown up at her house on multiple occasions. Officers signed an arrest warrant on the male suspect for violating the protection order.
- Officers responded to the One Way Farm for a combative juvenile. While enroute, dispatch advised that the aggressive juvenile struck a Fairfield City police officer who was on the scene. Fairfield PD subsequently arrested the juvenile and transported him to their police station. Prior to the assault, the juvenile damaged a One Way Farm employee's vehicle.
- Officers responded to Millikin Road at Morris Road for an overturned vehicle. The driver was a juvenile without a driver's license.
