MISCELLANOUS TOPICS OF INTEREST:

- There were <u>58</u> arrests and <u>75</u> charges.
- Officer Wargo attended a 24-hour training course on Close Quarter Tactics (Level 1) at Norse Tactical.
- Detectives signed felony warrants for Theft from a Person in a Protected Class after a male subject out of Tampa, FL scammed elderly victims out of \$9,500. The suspect is currently in custody in Florida for unrelated gun charges as well as a holder on our agency's charges.
- Detectives are investigating a theft offense involving an elderly victim (protected class). Charges are pending in that case against a known offender.
- Detectives were called out for a shooting that occurred in the 2000-block of Harvard Street. The suspect vehicle fled the area and the victim was treated for the gunshot wound. This case remains under investigation.
- Officers responded to Parkamo Avenue for a suicidal male with a gun. The subject took his.45 caliber handgun
 and displayed it outside while yelling for neighbors to call 911 and that he wanted to die suicide by cop. Officers
 confirmed the witnesses saw a handgun and responding officers located the subject on Tuley Road with a
 handgun in his waistband with his hand on it. Officers were able to de-escalate and take the subject into
 custody and then transported him for an evaluation.
- Officers responded to Walmart for a female shoplifter fleeing from staff. Officers located the suspect walking
 near Subway and detained her, but she attempted to flee and began to resist and kick at officers. Officers
 gained control of her and while in the rear of the cruiser, she repeatedly banged her head against the partition.
 She eventually calmed down and was charged with theft, resisting arrest, obstructing official business, and was
 recited for two outstanding warrants.
- Officers were dispatched to Walmart for a theft and assault. The suspect stiff-armed the LP Officer when she approached him, and a passerby chased the suspect into the parking lot. The situation escalated to a physical altercation and the suspect sustained multiple contusions to the face and mouth. The suspect was charged with theft, assault, and then booked into the BC Jail.
- Officers responded to the 2800-block of Hamilton-Mason Road for a dispute/fight call. A male subject was looking for his cat at the location he used to reside with an ex-girlfriend. The subject became irate when he could not find his cat and began yelling at the current renter. The subject and renter engaged in a physical fight and the subject got into his vehicle and ran over the current renter's wood fence. Charges filed on the male subject for his actions.

- Two females were found to have engaged in a physical altercation in the parking lot of Buffalo Wild Wings. One female followed the other female to the police department where another altercation occurred. Both females then fled down Princeton Road and again verbally confronted each other in a parking lot. The family of one member arrived on the scene to scream at officers and film the scene. There were conflicting stories, but officers established probable cause and ultimately arrested both females.
- Officers responded to a call of a subject who died as a result of a self-inflicted gunshot wound. While on-scene, officers located a marijuana-growing operation. This case remains under investigation.
- Officers responded to the 3900-block of Hamilton-Middletown Road for an active domestic violence call. A female was found to have started a physical altercation with her roommate. The female was booked into jail on domestic violence as well as an outstanding warrant for felony domestic violence through Butler County.
- Officers responded to Princeton by the Bridgewater Falls entrance for a vehicle that failed to make a proper left turn onto westbound Princeton Road from Bridgewater Falls. The unknown vehicle struck the large rocks and streetlight in the median and then fled the scene. Duke responded to the scene to turn off the electric.
- Officers responded to the 3600-block of Hamilton-Middletown Road for a truck sitting on the side of the roadway facing the wrong direction. Upon arrival officers located the running vehicle with a subject in the driver's seat. That driver was arrested for OVI and driving without a license.
- Officers responded to the 1900-block of Parkamo Avenue for an active burglary. Officers observed the male suspect inside the residence and the suspect attempted to flee out of a side window. Officers were able to take him into custody after a short foot pursuit. The subject was booked into the jail for burglary and outstanding warrants
- Officers responded to Menards for a theft offense. A male subject threw merchandise over the fence and then drove a vehicle up the grassy hill and started loading the merchandise into the car. The subject had a felony probation violation with a holder out of Xenia Ohio. He was booked arrested and booked into the jail.
- Officers were dispatched to Stallings Lane for a fight possibly involving a gun. The domestic dispute escalated but officers later determined no gun was involved. Intoxication and a decline in mental status was a contributing factor and all parties were separated and went elsewhere for the night.
- Officers responded to Walmart for a shoplifting in progress. The male subject was detained and charged with theft and drug abuse instruments after officers located syringes on him. The subject had a felony warrant through BC and he claimed he had just got out of quarantine for COVID but was allegedly still positive.
