- Personnel began obtaining their CPR recertification we anticipate everyone to be done in March.

TOPICS OF INTEREST:

Darrell Prewitt, Community Resource/Crime Prevention Specialist, took part in speaking during the 2021 Transition Bootcamp Virtual Conference. This conference, organized by the Cincinnati Children's Hospital Medical Center, had a target audience of families with family members who have autism or other disabilities as well as those professionals who work with those who have disabilities. The learning objectives were recognizing the importance of being engaged with law enforcement, direct support in proactive safety planning so that youth and adults with IDD can successfully navigate their communities, ideas on how to engage local law enforcement to ensure safety in crisis situations, and proactive strategies to support individuals with disabilities in their encounters within the community.

Darrell collaborated with Rachel Miller, Communications Coordinator for UC Center for Excellence in Developmental Disabilities and Anne Tapia, Regional Autism Advisory Council Coordinator for Southwest Ohio.

Darrell's presentation included discussions on Smart911, Text911, and crime prevention safety tips.

- Police Clerk Anita Snyder resigned following 16 years of service to the community. Anita started volunteering here at the PD upon completing the 2nd annual Citizen Police Academy in 2004. She then went part-time in Records and later full-time. Anita was a valued employee with a wonderful personality and enjoyed helping others.
- Officer Adam Green was sworn in as our newest police officer at the January 13, 2021 Trustees Meeting. Prior to working here at the township, Green was employed by the Butler County Sheriff's Office and served as a corrections officer in the jail.
- Two of the four police cruisers purchased in early 2020 are outfitted and went in-service in the past week.
- Body cameras were purchased from WatchGuard and will synchronize with the existing WatchGuard in-car audio/video cameras.

• Evening shift officers responded to the 4000-block of Hickory View Drive for a suspicious male bleeding from the mouth and going door-to-door asking people to let him in. At one house he pushed the residents aside and entered their house, went to the bathroom where he placed deodorant in his pocket. The male did not know who or where he was and shoved one of the officers on the scene. Following a brief struggle, officers were able to detain the male subject and transport him to the hospital for a psychiatric evaluation.

• Evening shift officers responded to Speedway on Creekside Drive for an active fight involving a male subject who attempted to steal a motor vehicle with an occupant sleeping inside it. That occupant woke up and started striking the subject and the owner was able to pull the subject out of the driver's seat. Officers took the subject into custody and booked him in at the Butler County Jail for Kidnapping (F2) and Theft [of a motor vehicle] (F4).

• Sergeant Miller and Officer Singleton responded to the 7900-block of Jessie's Way for a welfare check upon learning that family could not get ahold

of the 83-year old female who resided there. Officers eventually forced entry and found the elderly female on the bedroom floor. She was transported to the hospital due to suffering from a serious injury from a fall and she was not able to reach her phone. Both of these police officers are receiving a Letter of Commendation for their actions.

- Detectives intercepted a male subject who was communicating with an individual with a declined mental status and arranging sexual encounters at a retail store restroom. This case remains under investigation.
- Midnight shift officers stopped a vehicle and found the driver operating without a driver's license. One of
 the passengers was found to be under the influence of drugs and/or alcohol and was transported for a
 medical evaluation due to being highly intoxicated and going in and out of consciousness. The driver was
 cited and transported to the hospital to be with his friend.
- Day shift officers responded to the 6400-block of Liberty-Fairfield Road for a burglary in progress. Officer arrested a female subject and booked her in the BC Jail.
- Day shift responded to the 2000-block of Harvard for theft of a motor vehicle. The complainant stated the keys were left in the vehicle and an unknown person stole her vehicle overnight. The vehicle was located the next morning in the City of Hamilton.

- Day shift officers responded to the 6500-block of Jayfield Drive for a suspicious male dressed in all black looking around the front porches of houses. Officers located the subject and discovered he was under the influence of narcotics and not responding to questions. Officers had the life squad evaluate the subject due to his erratic behavior, which later escalated. The subject worsened and medical staff learned he ingested "bath salts".
- Day shift officers responded to the 3900-blcok of Hamilton-Middletown Road for several dogs being confined in one of the businesses. Entry was made into the business where officers located eight dogs (5 adult and 3 puppies), one deceased puppy, and one cat. The animals were removed and transported to the animal shelter. The subject staying there was in jail for felony domestic violence.
- Midnight shift officers responded to the 6200-block of Walden Ponds Circle for a traffic crash. The driver
 of the at-fault vehicle resides in the area and was found to be impaired at the time of the crash.
- Midnight shift officers responded to the 2000-block of Parrish Avenue for an overdose. Officers administered Narcan and the unconscious person became alert and refused being transported to hospital. The individual who overdosed was in town visiting family who still had a protection order against him. Since the subject was medically cleared, officers arrested him for violating the protection order.
- A midnight shift officer stopped a vehicle on Tuley Road for an illegal turn and the plate being unreadable. The driver was found to be driving under suspension and the passenger refused to give his information to officers. The passenger took fentanyl right after the vehicle was stopped and was provided Narcan and transported to the hospital.
- Midnight shift officers responded to Hamilton-Middletown Road and SR4 Bypass for a multiple injury crash. The driver of the at-fault vehicle fled the scene on foot prior to officers arriving. Officers later located the driver at the hospital and this matter remains under investigation.
- Midnight shift officers responded for a suspicious vehicle in the 2600-block of Arroyo Ridge. The vehicle
 was entered as stolen and was occupied by two subjects who had several warrants. Drug abuse
 instruments and unknown drugs were also found in the vehicle.
- Midnight shift officers observed a suspicious vehicle with fictitious plates in the 2000-block of Parrish Avenue. When the occupants noticed the police in the area, they quickly pulled into a driveway and fled into the woods. The vehicle was entered as stolen.
- Midnight shift officers assisted West Chester PD with a reckless operator in the 3900-block of Tylersville Road. The driver struck something in West Chester and was driving erratically on just the rim. WCPD stopped the vehicle in front of UDF and township officers arrested the subject for OVI.
- Midnight shift officers observed a traffic light in the middle of SR4-Bypass/Hamilton Mason and found the vehicle shortly afterward. The female driver was arrested for OVI.
- Midnight shift officers responded to an injury crash on Tuley Road/Imlay. Several subjects fled from the vehicle and officers located two of them. One was arrested for Disorderly Conduct while intoxicated and Obstructing Official Business.
